# Commercial Vendor Application

## Rules & Regulations

1. Vendor spaces will be assigned on a first come, first service basis. Businesses located on Main Street will have priority for space directly in front of their storefront. Subleasing of vendor space is prohibited.
2. All commercial applicants must have a NYS Certificate of Authority to Collect Sales Tax, which must be displayed at the vendor location. A photocopy of the original certificate must accompany this application. If a copy of the original certificate is not included, please provide an explanation:
3. Applicants must meet all electrical codes. If it is determined, at the sole discretion of the Greater Greenwich Chamber of Commerce (GGCC), that the applicant is using electricity for an unapproved or unsafe use, the GGCC may terminate electrical access.
4. All vendors will be placed on Main Street from Hill Street to Washington Street. Use of sidewalk is not allowed as it obstructs flow of pedestrians and blocks access to businesses and residences.
5. Set up is on Saturday, June 17 from 9:00am to 11:00am. Take down is from 6:00pm to 7:00pm.
6. Once you have been assigned your vendor space, you may temporarily load and unload along Main Street, but you must move your vehicle upon completion. Parking will be allowed on side streets and in designated lots only. No parking will be allowed on Main Street between Hill & Washington.
7. Applicant is responsible for the removal of all trash, packing materials, boxes, etc.
8. Please do not leave valuables unattended, the GGCC assumes no responsibility for lost/stolen items.
9. Flea market items and flea market type vendors are prohibited.
10. The festival is a family event and the GGCC reserves the right to reject any items listed on this application or from your display. Prohibited items include, but are not limited to: switchblades, long knives, short knives, poppers, cap guns, smoke bombs, stink bombs, fireworks, stretch bottles, explosives, sticky string, silly string, marshmallow shooters, drug paraphernalia, laser pointers, lighters, tobacco products, and alcoholic beverages.
11. If it is determined, at the sole discretion of the GGCC, that the applicant is not in compliance with any of the regulations as set forth herein or fails to remove any items upon request by the GGCC, that the GGCC considers incompatible with community or safety standards, the GGCC may expel the applicant from the festival, without a refund.

I understand that this application is not a guarantee of festival space. By submitting this application, I hereby agree to abide by the rules and regulations governing the festival as set forth herein, and any others that may be implemented. I understand that your failure to abide by these rules may result in expulsion from the festival.
